- Reviewed, discussed, and approved the 2019 Annual Meeting Minutes.
- Reviewed, discussed, and approved the 2019 Financial Budget, Treasurer's Report, and Proposed Budget for 2020. Discussion topics prior to approval:
  - 1. Requests for a basketball hoop and pressure washing the basketball court were made by attendees. We discussed getting a volunteer group together to make these things happen, as well as increasing overall attendance at our monthly HOA meetings to make things like this happen in our neighborhood.
  - 2. A discrepancy was raised regarding the landscaping budget and actual spending; Jeff is going to look into this.
  - 3. A question was raised about putting garbage cans in the park. The issue is having someone in charge of removing the garbage and or the cost of paying a company to do it for us.
  - 4. We discussed collections; members who are historically on time with paying dues; those behind; those several years behind; and members who will have liens placed on their homes once they are sold or foreclosed on. We discussed the few (approximately 30) members who claim they are "grandfathered in" and do not have to pay dues, however, this is not true. They are held responsible for paying dues and abiding by Ponderosa HOA CC&Rs and by-laws.

- 5. A request was made to move the location of our monthly meetings to public location. This may be discussed at our February meeting.
- 6. The park was a hot topic. Again, we are encouraging residents to attend our monthly meetings. With all the anticipated new volunteers at the meeting, we will be forming another Park Improvement Committee.
