Bonney Lake Police: 10 Ways To Reduce Auto Break-Ins Tips for the holiday season.

As the holiday shopping season begins the Bonney Lake Police Department is concerned about Vehicle Break-Ins. We don't want you to be the next victim.

Are any of these items visible in your vehicle? Cell Phone or GPS Unit – Music CD's or Stereo Faceplate – Purse and/or Wallet – Shopping Bags, Clothes, Merchandise, Backpacks – Laptop or Other Electronic Equipment – Sporting Equipment or Tools – Checkbooks or Other Papers for Identity Theft

You can prevent vehicle break-ins. Vehicle break-ins only take a few minutes, especially when the car is left unlocked or when thieves smash windows to grab items they see inside.

Criminals often drive through parking lots looking for vehicles with open windows and/or unlocked doors or any valuables left out in the open.

If you must leave valuables in a vehicle, do conceal items BEFORE arriving at your parking space, if possible. Be aware that vehicle break-ins commonly lead to other crimes such as fraud and identity theft – so limit the amount of personal information you keep in your vehicle. Protect yourself and don't become the next victim.

Imaginative Gifts for Seniors

For almost everyone who gives gifts at Christmas, there's one or two people who are elderly. Many of them seem not to need or want more "stuff" in their lives. If your friend or relative is confined to a senior residence or home, finding the right gift is even tougher. In this situation, space for things is often an issue. So what's a gift giver to do? Here are 10 unusual and frugal ideas that will bring a smile to even the most over-stuffed senior.

1. Ergonomic kitchen tools - Years ago, a friend gave me a potato peeler with an ergonomic handle, and I haven't stopped using it since. I know she didn't pay more than \$6 for it, but it's one of the best Christmas gifts I ever got. Jar openers, spatulas, corn peelers, etc. can be found in most discount department stores or viewed and ordered online. Your friend with arthritis in her thumbs like me, will love you for it!

Recordable greeting card - These are so cool. Try a karaoke card and record your own voice singing old time favorites. Jokes? Even better. Drug stores, card shops, and supermarkets carry them and they cost between \$6 to \$10.

- 3.Stuffed calendars Purchase a calendar with a motif your friend will love and then go through and mark important dates, such as birthdays of friends and family, upcoming events, and anniversaries. Pre-marking them for your gift recipient will show your thoughtfulness and maybe help remind you, too! Package a few stamped greeting cards along with the calendar if you want to make it extra special.
- 4.Trip back in time Gather some old photos of your senior, perhaps from an event like a wedding or important birthday. Tape one to the cover of a pretty tin filled with old time candies, like Necco Wafers or Mary Janes. Place remaining photos in a Christmas card. Crank it up a notch with a subscription to Good Old Days or Reminisce . I did this for my own Mom for years and she looked forward to every issue.
- 5.Deck of cards Either poker or pinochle will do and get a new score pad and some sharpened pencils. Add a few coupons for card games with you!
- 6. Yourself Almost nothing beats a visit from you, especially if your senior is homebound. Make a commitment to them in your heart and do it. Your thoughtfulness will shine through and you'll benefit as much or more than they will.

Schedule your gift delivery day and call ahead to make sure it's convenient. Put a bow in your hair or wear a red tie. Let your senior know you love them and care about how they celebrate the holidays. Jingle Bells at the top of your voice would not be inappropriate!

































Making Sure Your Gift Goes Where you Want it to go... Avoiding Charity Scams

Without charities and other non-profit organizations, many vital services would not be available in the United States. The latest numbers from the "Giving USA" report are both encouraging and mind boggling. Americans gave \$335.17 in charitable donations, an increase of four percent from 2013. Giving by corporation declined almost 2 percent, which means their was a major upswing in individual donations. As these tax-exempt organizations continue to increase in number, competition for funds will become more competitive and mailboxes will fill up with even more fund-raising appeals. While most of these charities are legitimate, unfortunately, a small minority are not. If you are not careful, you may find yourself funding an organization's administrative costs or lining the pockets of scam artists instead of supporting a worthy cause. Before making a donation, consider the following tips: 1. Get Off the Telephone: No reputable charity will ask you to donate over the telephone. If you receive such a call, simply request written literature and a copy of the charity's latest report. 2. Check the Numbers: No more than forty percent of donations should be used to cover general administration and fund-raising costs. If the organization is new, this percentage may be slightly higher. Be wary of charities that use the label "public education" to hide large portions of their direct mail and telemarketing expenses. 3. Do Not Respond to Pressure: You have a right to say no. Do not allow an aggressive caller to pressure you into sending a check and possibly exposing yourself to identity fraud. Hang up immediately if the caller persists. Also, keep in mind that you are not obligated to make a contribution to keep greeting cards, address stickers, calendars, key rings, and other "gifts" sent in the mail. It is against the law for a charity to demand payment for any unordered merchandise. 4. Double-Check the Name: Some charities use names that closely resemble well-known, legitimate organizations. Con artists can easily impersonate a reputable charity, sending e-mails with a well-known logo with a link that directs donors to a different website. If the name sounds suspicious, check with your state charity registration office before making a contribution.
